

INTRODUCTION

The Business Choice Program gives dealers unmatched flexibility to tailor new Chevrolet and GMC vehicles to meet the exact needs of their business customers. Created with the same focus as our award-winning vehicles, Chevrolet and GMC Business Choice Offers will help you to grow your Commercial business.

Beginning in 2020, Business Choice incentives will transition from a calendar year (CY) program to a model year (MY) program. This move recognizes the dynamic nature of the Commercial market, simplifying incentive messaging and program management.

Be sure to present Business Choice Offers to your customers on every eligible vehicle. For your reference, the chart on the following page provides a comprehensive overview of the Program.





ELIGIBLE CORE/NON-CORE COMMERCIAL VEHICLES

As the name implies, the Business Choice incentive is for business owners who use their vehicles exclusively or primarily for business needs.

- Core Commercial vehicles do not require proof of business ownership
- Non-Core Commercial vehicles do require proof of business documentation

CUSTOMER ELIGIBILITY

Determining customer eligibility for Business Choice requires documentation and a few basic questions. As you are qualifying business prospects, be alert for the professions and occupations indicated by the categories below:

Customers who select eligible non-core Commercial vehicles can still receive Business Choice incentives; however; they must be able to answer "yes" to both of the following questions and provide supporting documentation:

- 1. Are you a business owner?
- 2. Is the vehicle used in the day-to-day operations of your business and not solely for personal nonbusiness transportation purposes?

VERIFYING BUSINESS OWNERSHIP

- Farmer's General Liability Insurance
- Articles of Incorporation

- Municipalities (in lieu of bid assistance; vehicle must be in name of municipality)

For non-core Commercial vehicles that are reported sold in the name of the individual, (in lieu of the business name,) the dealership must obtain and retain an eligible document that provides proof the individual is a business owner.

- Download the Parts Estimate PDF in the Business Choice portal for your parts and service departments to support the installation of the selected Business Choice accessories.
- Sales Consultants and Sales Managers are eligible for spiffs on accessories sold through this Program. For more information, visit the "Spiff" section found under "Program Info" in the Business Choice portal.

Upfit Cash Allowance

To qualify for Upfit Cash:

- The invoice amount for the selected upfits must meet or exceed the amount of the incentive.
- Eligible upfits must be installed by an approved third-party upfitter.
- Refer to the Upfit Cash Administrative Messages in GlobalConnect for a list of eligible upfits.

Upfit Cash PLUS Accessory Cash Allowance (Express and Savana Cargo Vans ONLY)

- Add eligible accessories to your Express or Savana Cargo Van claims.
- To qualify for Upfit Cash, the combined invoice amount for the selected upfits and accessories must meet or exceed the amount of the incentive.
